The Wisconsin State Electrical Code is issued and administered by the Public Service Commission and the Department of Labor and Human Relations as part of the Wisconsin Administrative Code. The Public Service Commission has primary responsibility for issuance and administration of Volume 1 which is found in chapter PSC 114. The Department of Industry, Labor and Human Relations has similar responsibility for issuance and administration of Volume 2 which is found in chapter ILHR 16.

## WISCONSIN STATUTE 101.865 (1):

**101.865 REGULATION OF ELECTRIC WIRING.** (1) It is hereby made the duty of every contractor and other person who does any electric wiring in this state to comply with the Wisconsin state electrical code, and the company furnishing the electric current shall obtain proof of such compliance before furnishing such service; provided, that nothing therein contained shall be construed as prohibiting any municipality from making more stringent regulations than those contained in the Wisconsin state electrical code. Proof of such compliance shall consist of a certificate furnished by a municipal or other recognized inspection department or officer, or if there is no such inspection department or officer it shall consist of a written statement furnished by the contractor or other person doing the wiring, indicating that there has been such compliance.

**IMPORTANT:** Before electricity can be furnished, this written statement, signed by the licensed electrician doing the wiring, must be submitted to the office of Northwestern Wisconsin Electric Company at Grantsburg or Frederic. Please note that the wiring, prior to connection, must also be in compliance with certain additional installation requirements of the utility which are not stated in the Wisconsin State Electrical Code.
